## Amendments to the MRA Rule of Racing 71 and MRA Regulation 34.1.2

Annex A sets out the amendments (highlighted in bold) to MRA Rule of Racing 71 and MRA Regulation 34.1.2 for implementation effective from 19 August 2017.

## **Registrations of Professional Trainer Licences**

- Applications for Professional Trainer licences by Brian William Dean, David Lee Freedman and Stephen Graham Crutchley were officially registered with MRA.
- They have six months (till 21 February 2018) to secure stabling facilities at any of the four associated Clubs, failing which their registrations will lapse.

## **AMENDMENTS TO MRA RULE OF RACING 71 AND MRA REGULATION 34.1.2**

## MRA RULE OF RACING

PART VIII: HORSES

Certificate of Registration

## **Rule 71**

Upon registration of a horse, the Secretary of the Association shall issue a Certificate of Registration to the applicant **upon request**. In addition, an Equine Passport shall be issued by the Association in respect of every horse registered.

## MRA REGULATION

PERSONS: LICENCED OR REGISTERED

## Regulation 34.1.2

In addition, the applicant must satisfy the following criteria:

- (a) Must be at least twenty one (21) years of age and not older than sixty-seven (67) years of age;
- (b) Passed written and oral tests if required by the Stipendiary Stewards based on the applicant's years of experience as a Professional Trainer with an overseas Racing Authority;

- (c) Passed a practical test if required by a panel consisting of an MRA Trainer representative, a Veterinary Surgeon and an MRA Stipendiary Steward based on the applicant's years of experience as a Professional Trainer with an overseas Racing Authority;
- (d) Obtained a **clearance** by the Stipendiary Stewards;
- (e) Have a good disciplinary record in racing;
- (f) Have produced owners' support for a minimum of fifteen (15) horses;
- (g) Provide a banker's references which should indicate his financial standing and show that he had maintained an active account for the past three years and has a balance in fixed deposits and current account savings, exceeding S\$100,000/RM250,000 for the six months immediately preceding the date of application for a licence;
- (h) Deposited a banker's guarantee or cash deposit of an amount to be determined by his Club; and
- (i) Passed a medical examination by a MRA-approved doctor.
